- 2. Election of chairman for the coming year Denis Pye was unanimously elected, he signed the acceptance form and took the chair.
- 3. Vice-chairman Thelma Brown was proposed and unanimously elected.
- 4. Co-option of new councillor Clare Rix was proposed and duly elected.
